- Over the 2021-2023 period, 5.4 5.5% of all motor vehicle crashes and 4.7 6.9% of all fatalities involved drivers aged 16-18.
- During 2023, drivers aged 16-18 were overrepresented in crashes; drivers of this age group constituted 3.5% of all drivers involved in crashes but only 1.5% of all licensed drivers.

- F&PI crashes involving drivers aged 16-18 were more likely to involve multiple vehicles than all F&PI crashes (80.3% versus 69.3% in 2023).
- Drivers aged 16-18 involved in F&PI crashes were more likely to be driving with passengers than drivers in all F&PI crashes (36.5% versus 25.6% in 2023).

- In 2023, crashes involving drivers aged 16-18 were most likely to occur between 3pm-6pm (27.1%) which is the same as the time period for the most crashes involving all drivers.
- In 2023, the largest proportion of fatal crashes involving drivers aged 16-18 occurred 9pm-12am (26.7%). Personal injury and property damage crashes involving this age group were most likely during the 3pm-6pm period.

- In 2023, the top three contributing factors for drivers aged 16-18 in F&PI crashes were Failure to Yield Right-of-Way (18.6%), Driver Inattention/Distraction (14.9%), and Unsafe Speed (14.7%).
- In 2023, drivers aged 16-18 in F&PI crashes were more likely than all drivers in F&PI crashes to have Driver Inexperience and Unsafe Speed reported as contributing factors (10.0% versus 1.9% and 14.7% versus 6.7%, respectively).

- In 2023, speeding violations were the most common ticket category issued to drivers aged 16-18. 26.6% of the tickets issued to drivers aged 16-18 were for speeding violations, compared to 18.9% of the tickets issued to all drivers.
- In 2023, 0.7% of the TSLED tickets issued to drivers aged 16-18 were for impaired driving versus 2.2% of the TSLED tickets issued to all drivers.

- In 2023, 54.2% of the F&PI crashes involving drivers aged 16-18 occurred in the Upstate region, 27.9% were on Long Island and 17.9% in New York City.
- In 2023, 67.1% of the fatalities in crashes involving drivers aged 16-18 occurred in the Upstate region, while 15.8% occurred on Long Island and 17.1% were in the five boroughs of New York City.
- During 2023, drivers aged 16-18 were underrepresented in F&PI crashes in the Upstate region (54.4% of the drivers involved in crashes vs. 62.7% of the licensed drivers), overrepresented in crashes in the Long Island region (28.1% of the drivers involved in crashes vs. 24.3% of the licensed drivers), and overrepresented in NYC (17.5% of the drivers involved in crashes vs. 13.0% of the licensed drivers).
