- Over the 2021-2023 period, 11.1 11.8% of all motor vehicle crashes and 9.9 12.9% of all fatalities involved drivers aged 16-20.
- During 2023, drivers aged 16-20 were overrepresented in crashes; drivers of this age group constituted 7.4% of all drivers involved in crashes but only 3.7% of all licensed drivers.

- F&PI crashes involving drivers aged 16-20 were more likely to involve multiple vehicles than all F&PI crashes (81.3% versus 69.3% in 2023).
- Drivers aged 16-20 involved in F&PI crashes were more likely to be driving with passengers than drivers in all F&PI crashes (33.1% versus 25.6% in 2023).

- In 2023, crashes involving drivers aged 16-20 were most likely to occur between 3pm-6pm (26.1%) which is the same as the time period for the most crashes involving all drivers.
- In 2023, the largest proportion of fatal crashes involving drivers aged 16-20 occurred 9pm-12am (23.4%). Personal injury and property damage crashes involving this age group were most likely during the 3pm-6pm period.

- In 2023, the top three contributing factors for drivers aged 16-20 in F&PI crashes were Failure to Yield Right-of-Way (16.1%), Driver Inattention/Distraction (14.5%), and Following Too Closely (14.0%).
- In 2023, drivers aged 16-20 in F&PI crashes were more likely than all drivers in F&PI crashes to have Unsafe Speed and Driver Inexperience reported as contributing factors (13.5% versus 6.7% and 7.4% versus 1.9%, respectively).

- In 2023, speeding violations were the most common ticket category issued to drivers aged 16-20. 26.2% of the tickets issued to drivers aged 16-20 were for speeding violations, compared to 18.9% of the tickets issued to all drivers.
- In 2023, 0.9% of the TSLED tickets issued to drivers aged 16-20 were for impaired driving versus 2.2% of the TSLED tickets issued to all drivers.

- In 2023, 49.4% of the F&PI crashes involving drivers aged 16-20 occurred in the Upstate region, 26.6% were on Long Island and 24.0% in New York City.
- In 2023, 57.7% of the fatalities in crashes involving drivers aged 16-20 occurred in the Upstate region, while 23.2% occurred on Long Island and 19.0% were in the five boroughs of New York City.
- During 2023, drivers aged 16-20 were underrepresented in F&PI crashes in the Upstate region (49.5% of the drivers involved in crashes vs. 57.1% of the licensed drivers), overrepresented in crashes in the Long Island region (27.0% of the drivers involved in crashes vs. 23.7% of the licensed drivers), and overrepresented in NYC (23.5% of the drivers involved in crashes vs. 19.1% of the licensed drivers).
