- Over the 2021-2023 period, 8.5 9.3% of all motor vehicle crashes and 8.0 9.0% of all fatalities involved drivers aged 18-20.
- During 2023, drivers aged 18-20 were overrepresented in crashes; drivers of this age group constituted 5.5% of all drivers involved in crashes but only 3.0% of all licensed drivers.

- F&PI crashes involving drivers aged 18-20 were more likely to involve multiple vehicles than all F&PI crashes (82.1% versus 69.3% in 2023).
- Drivers aged 18-20 involved in F&PI crashes were more likely to be driving with passengers than drivers in all F&PI crashes (31.2% versus 25.6% in 2023).

- In 2023, crashes involving drivers aged 18-20 were most likely to occur between 3pm-6pm (25.4%) which is the same as the time period for the most crashes involving all drivers.
- In 2023, the largest proportion of fatal crashes involving drivers aged 18-20 occurred 9pm-12am (23.7%). Personal injury and property damage crashes involving this age group were most likely during the 3pm-6pm period.

- In 2023, the top three contributing factors for drivers aged 18-20 in F&PI crashes were Failure to Yield Right-of-Way (14.6%), Following Too Closely (14.5%), and Driver Inattention/Distraction (14.3%).
- In 2023, drivers aged 18-20 in F&PI crashes were more likely than all drivers in F&PI crashes to have Unsafe Speed and Following Too Closely reported as contributing factors (13.0% versus 6.7% and 14.5% versus 10.2%, respectively).

- In 2023, speeding violations were the most common ticket category issued to drivers aged 18-20. 26.6% of the tickets issued to drivers aged 18-20 were for speeding violations, compared to 18.9% of the tickets issued to all drivers.
- In 2023, 1.0% of the TSLED tickets issued to drivers aged 18-20 were for impaired driving versus 2.2% of the TSLED tickets issued to all drivers.

- In 2023, 46.8% of the F&PI crashes involving drivers aged 18-20 occurred in the Upstate region, 26.3% were on Long Island and 26.9% in New York City.
- In 2023, 50.5% of the fatalities in crashes involving drivers aged 18-20 occurred in the Upstate region, while 28.3% occurred on Long Island and 21.2% were in the five boroughs of New York City.
- During 2023, drivers aged 18-20 were underrepresented in F&PI crashes in the Upstate region (46.7% of the drivers involved in crashes vs. 54.6% of the licensed drivers), overrepresented in crashes in the Long Island region (26.7% of the drivers involved in crashes vs. 23.9% of the licensed drivers), and overrepresented in NYC (26.6% of the drivers involved in crashes vs. 21.4% of the licensed drivers).
