- Over the 2021-2023 period, 20.5 22.2% of all motor vehicle crashes and 20.7 21.6% of all fatalities involved drivers aged 18-24.
- During 2023, drivers aged 18-24 were overrepresented in crashes; drivers of this age group constituted 13.9% of all drivers involved in crashes but only 8.3% of all licensed drivers.

- F&PI crashes involving drivers aged 18-24 were more likely to involve multiple vehicles than all F&PI crashes (82.6% versus 69.3% in 2023).
- Drivers aged 18-24 involved in F&PI crashes were more likely to be driving with passengers than drivers in all F&PI crashes (28.9% versus 25.6% in 2023).

- In 2023, crashes involving drivers aged 18-24 were most likely to occur between 3pm-6pm (24.4%) which is the same as the time period for the most crashes involving all drivers.
- In 2023, the largest proportion of fatal crashes involving drivers aged 18-24 occurred 12am-5am (22.3%). Personal injury and property damage crashes involving this age group were most likely during the 3pm-6pm period.

- In 2023, the top three contributing factors for drivers aged 18-24 in F&PI crashes were Driver Inattention/Distraction (14.4%), Following Too Closely (13.5%), and Failure to Yield Right-of-Way (13.1%).
- In 2023, drivers aged 18-24 in F&PI crashes were more likely than all drivers in F&PI crashes to have Unsafe Speed and Following Too Closely reported as contributing factors (11.5% versus 6.7% and 13.5% versus 10.2%, respectively).

- In 2023, speeding violations were the most common ticket category issued to drivers aged 18-24. 23.2% of the tickets issued to drivers aged 18-24 were for speeding violations, compared to 18.9% of the tickets issued to all drivers.
- In 2023, 1.5% of the TSLED tickets issued to drivers aged 18-24 were for impaired driving versus 2.2% of the TSLED tickets issued to all drivers.

- In 2023, 42.7% of the F&PI crashes involving drivers aged 18-24 occurred in the Upstate region, 23.8% were on Long Island and 33.5% in New York City.
- In 2023, 56.3% of the fatalities in crashes involving drivers aged 18-24 occurred in the Upstate region, while 20.5% occurred on Long Island and 23.1% were in the five boroughs of New York City.
- During 2023, drivers aged 18-24 were underrepresented in F&PI crashes in the Upstate region (42.6% of the drivers involved in crashes vs. 51.1% of the licensed drivers), overrepresented in crashes in the Long Island region (24.4% of the drivers involved in crashes vs. 22.1% of the licensed drivers), and overrepresented in NYC (33% of the drivers involved in crashes vs. 26.7% of the licensed drivers).
