Dr. Austin V. Angulo is an Assistant Professor in the Department of Civil, Structural and Environmental Engineering at University at Buffalo (UB). His research interests include CAV technologies, vulnerable road user safety, micromobility, human factors in transportation, virtual reality simulation and transportation sustainability and equity. At UB, Dr. Angulo founded the

Transportation Research and Visualization Laboratory (TRAVL), a state-of-the-art facility dedicated to the research, training, and education of human interaction with transportation infrastructure using naturalistic and immersive virtual simulation methodologies. Brandi Behling is the Motorcycle Safety Foundation's Program Manager of the New York State Motorcycle Safety Program. She is focused on delivering high-quality rider education, building partnerships and promoting safer roads for riders and drivers. Behling has been an MSF-certified RiderCoach since 2017, teaching more than 240 courses including the Basic *RiderCourse*, 3-Wheel Basic *RiderCourse*, and the Basic *RiderCourse2*. Her deep understanding of the RiderCoach Guide, the New York State Motorcycle Safety Program Policies & Procedures, and RiderCoach Rules of Professional Conduct make her a valuable resource for other coaches and site managers. Behling continues to teach Basic *RiderCourse* classes and conducts Quality Assurance Visits while overseeing the state program. She is always looking to help expand the base of quality RiderCoaches in New York and is often recruiting and vetting RiderCoach candidates. She also advises training providers on training bikes and compliance. Prior to working for the Motorcycle Safety Foundation, Behling worked with court systems and school districts. She holds an MBA from the University of Phoenix and a Master's Degree in Human Resources.

Mary Harding is the Highway Safety Bureau Director at the NYS Department of Transportation within the Office of Traffic Safety and Mobility, overseeing Highway Safety Improvement Program funding, the development of the Strategic Highway Safety Plan, Permit Issuance and Work Zone Traffic Control Quality Assurance. She previously worked in the Department's Design-Build program in the Project Management Office; oversaw the Transportation Alternatives Program (TAP) and Safe Routes to School (SRTS) program within the Local Programs Bureau; and managed State Government Relations. Prior to joining the Department in April 2006, she worked in the Governor's Office and the NYS Senate for 8 years. Mary holds a Bachelor's and Master's degree from the State University of New York at Albany's Rockefeller College.

Christopher Roscoe started working as a Highway Safety Program Representative at the NYS Governor's Traffic Safety Committee in July 2025. He is passionate and experienced motorcyclist who prefers Harley Cruisers/Touring. Technology to Better Understand and Prevent Distracted Driving

Concurrent Session 2B, Ballroom B & C

This session will share how the Insurance Institute for Highway Safety is exploring how we can use technology to better understand and prevent distracted driving. The presentation will preview an upcoming study that links telematics crash data with police crash reports to better understand the magnitude of underreporting in police crash reports. To better prevent distracted driving, the Institute surveyed owners of Subaru's equipped with DriverFocus, a driver attention system designed to alert the driver when distraction and drowsiness are sensed and redirect their attention back to the road. Nearly 9 in 10 drivers

surveyed drive with the system on most or every time they drive, and there is general agreement among the sample that the system can provide safety benefits.

Sheriff Allard, a resident of Caton, is a US Army veteran who joined the City of Corning Police Department in 1988 and retired in 2009 after rising from patrolman to Lieutenant. After his retirement, Sheriff Allard worked part-time as a police officer for the Town of Caton and the Village of Painted Post, Town of Corning Constable, and court security for the towns of Corning, Hornby and Lindley until 2013. He also served as a session director for the Southern Tier Law Enforcement Academy at Corning Community College and served as an adjunct instructor at the school until his appointment to his post of Undersheriff in 2013. Sheriff Allard has been married since 1987 to his wife, Wendy, and they have three adult children, one daughter-in-law, one son-in-law and two grandchildren.

Kim Clark is a Dispatcher with the Steuben County Sheriff's Office and the mother of Emilee Rawleigh, a 21-year-old woman who passed away after being involved in a crash in 2019. Emilee was not wearing a seatbelt and distracted her driver in the final moments before the fatal collision in Cohocton. Kim now travels to schools and communities to tell Emilee's story.

Navigating the Evolving Vehicular Crimes Landscape: Legal Updates and Emerging Challenges

Presenter Biography:

Prior to her appointment as the Traffic Safety Resource Prosecutor, ADA Dellinger was a prosecutor in Nassau County since 2008. While there, she spent over a decade prosecuting vehicular crimes including multiple high-profile cases where individuals had been seriously injured or killed by drunk, drug impaired, or reckless drivers. ADA Dellinger rose through the ranks and was promoted to numerous supervisory positions including Deputy Bureau Chief of their misdemeanor DWI Unit, and later as the Deputy Bureau Chief of their felony Vehicular Crimes Bureau.

Partnerships Advance Road Safety in New York State Through the Crash Outcome Data Evaluation System (CODES)

Session 3C, Rooms 2 & 3

Description: The Crash Outcome Data Evaluation System (CODES) in New York State (NYS) is a powerful tool for investigating modifiable factors and emerging trends and issues in road traffic crash deaths, injury, and related medical diagnoses and costs. CODES is created through multi-agency data cooperation using probabilistic linkage that matches individual records from the NYS Department of Health (DOH) Statewide Planning and Research Cooperative System (SPARCS) database of emergency department (ED) visits and hospitalizations to the NYS Department of Motor Vehicles (DMV) Accident Information System (AIS) police and motorist crash reports. CODES includes data on road users, user behaviors such as impairment/speeding, injury characteristics, vehicles, roadways, crash and environmental characteristics and post-crash care.

Presenter Biographies:

Michael Bauer, MS, is the Director of the Bureau of Occupational Health and Injury Prevention at the New York State Department of Health. He has been working in injury and violence surveillance, epidemiology, and prevention for over 22 years and is committed to moving research to practice, ensuring that evidence-based programs are reaching the appropriate populations. As Bureau Director, he provides leadership, guidance, and direction with a focus on translating data into action. He has co-authored several peer reviewed articles and his work has been presented at numerous national and state conferences. He is a principal investigator on three grants from the Governor's Traffic Safety Committee.

Dr. Joyce Pressley is Faculty in the Departments of Epidemiology and Health Policy and Management at Columbia University where she teaches and directs the Outreach Core for the Columbia Center for Injury Science and Prevention. Dr. Pressley's experience crosses the disciplinary boundaries of public health policy, epidemiology, emergency medicine, critical care, economics and health care management. She has been a frequent collaborator with the New York State Department of Health on their Crash Outcomes Data Evaluation System. She has coauthored studies on using the safe system approach to understand motor vehicle crashes in NYS.

Leah Hines is an Epidemiologist and Unit Head for Injury Epidemiology and Surveillance in the Bureau of Occupational Health and Injury Prevention (BOHIP). Having been with BOHIP for 14 years, her work includes applying data to identify issues and inform prevention strategies on variety of injury topics, including motor vehicle traffic injuries, self-harm, older adult falls, and

violent deaths. She has worked as an Epidemiologist and Program Manager for the Crash Outcome Data Evaluation System (CODES) in her time with BOHIP, using CODES and many other data sources to evaluate and inform traffic safety program activities, to build partnerships, and to prevent injuries and deaths. She has her Master of Public Health (MPH) with a concentration in Epidemiology from the University at Albany School of Public Health.

Wen Zhang is a Ph.D. candidate in Computer Science and Engineering at the State University of New York at Buffalo. Her research focuses on data-driven artificial intelligence and optimization for transportation safety and mobility, including safe driving speed prediction, as well as vehicle routing problems with pickup and delivery.

Dachuan Zuo is a Ph.D. candidate in Transportation and Highway Engineering at New York University (NYU) Tandon School of Engineering, under the advisement of Dr. Kaan Ozbay. His research focuses on Al-driven traffic safety modeling, digital twin integration, and machine learning applications in transportation systems. He has contributed to the development of Al-powered tools for traffic risk assessment and congestion prediction, and digital-twin platforms for traffic flow prediction and safety evaluation. His work also includes safety potential field modeling for real-time collision risk quantification, graph neural networks for large-scale traffic forecasting, and physics-informed imitation learning for driving behavior modeling. Dachuan previously earned his M.S. from Northwestern University and a B.S. from Southwest Jiaotong University. His research has been presented at IEEE ITSC and TRB Annual Meetings.

Vision Zero - Safety Action Plans

Criminal Charges in Fatal Motor Vehicle Crashes

Traffic Safety - A Core Mission of Policing

Session 6A, Ballroom A

Description: Serious crashes and hazardous driving continue to plague our roadways causing deaths, injuries, property damage and economic losses. Law enforcement professionals should recognize that traffic safety is public safety and therefore traffic safety must be an integral part of an agency's policing operation. A comprehensive traffic safety plan is more than simply enforcement and can produce long-term positive impact for both the agency and the community it serves. Micro-modal, multi-agent extended reality simulation to improve safety with connected automated vehicles (CAVs)

Session 8C, Rooms 2 & 3 (Note: This presentation ends at 2:10 PM)

Description: Connected and automated vehicle (CAV) technologies can be leveraged to enhance safety, mobility, and sustainability. Two of the main challenges for large-scale deployment of CAV technologies are: a) certifying safety in dynamic scenarios involving humans and b) integrating vulnerable micro-modalities into the CAV network. Although significant research efforts have been dedicated to solving these problems, the majority of research results have only been tested in simulations with limited open datasets. Physical testing facilities, access to which is even more limited, typically rely on human and synthetic actor interactions and rarely include multiple humans within the same environment or scenario. MCity at the University of Michigan is the world's first controlled environment specifically designed to test and validate CAV technologies. Its recently announced testing capability of extended reality (XR), which bridges virtual testing and physical testing, creates new opportunities for CAV environment and scenario development, verification, and validation, SUNY University at Buffalo was awarded access to Mcity resources including a virtual "digital twin" of their testing facility, embedded naturalistic traffic simulation, and XR physical testing capabilities. We aim to expand the existing virtual and physical testing infrastructure capabilities of MCity by integrating human-in-the-loop, multi-modal simulators including vulnerable micro-modalities (e.g., pedestrian, bicycle) to develop safe and realistic testing environments for dynamic CAV and human interactions. Additionally, we will conduct multi-agent testing and verify CAV operations, including real-time dynamic interactions between humanoperated vehicles and micro-modalities with CAVs. Upon establishing these novel capabilities, we will investigate both CAV algorithms design & validation, and human behavior modeling. We will examine a variety of egress scenarios in safety-critical cases, including both human-driver versus CAV interaction and CAV-pedestrian interaction.

State of New Jersey vs. Olenowski: The DRE from Roadside to the NJ Supreme Court

Session 9A, Ballroom A

Description: This presentation will explore the legal trajectory of *New Jersey v. Olenowski*, tracing its path and culminating in its landmark consideration by the New Jersey Supreme Court. Attendees will gain insight into the pivotal legal questions raised in the case, particularly surrounding the admissibility and reliability of Drug Recognition Expert (DRE) testimony in impaired driving prosecutions. In addition to the case overview, the presentation will provide a comprehensive breakdown of the standardized 12-step DRE evaluation process used by law enforcement to assess drug impairment. This session is designed for legal professionals, law enforcement, and forensic experts.

Presenter Biography:

Assistant Attorney General Erik Daab is the Deputy Director of the New Jersey Division of Criminal Justice overseeing the State's Trial and Complex Litigation Bureau. He was previously Chief of the Specialized Crimes Bureau, where he oversaw several investigative units including the Casino Crimes Unit, the Atlantic City Violent Crime Task Force, and the Auto Theft Task Force. Prior to that, he was Deputy Chief of the Gangs and Organized Crime Bureau, where he prosecuted large-scale narcotics and weapons trafficking cases. He previously served in the Appellate Bureau, Corruption Bureau, and as Chief of the Medicaid Fraud Control Unit. Erik started his career working on death penalty cases for the Tennessee Office of the Attorney General and was the State Witness for the execution of the first inmate executed in Tennessee in forty years.

After graduating from Clarkson University, he worked for HNTB in Boston where he worked on the two premier projects in the state; the Central Artery/Third Harbor Tunnel Project, also known as the "Big Dig", and the New Route 146/US Route 20 Interchange with the Massachusetts Turnpike. After 8 years in Boston, he moved back to his hometown of Syracuse and worked for the local MPO for 4 years. He then worked for CHA, Inc. for 18 years managing traffic engineering and transportation planning projects throughout the east coast and Midwest. The past 8 years he has been a Sr. Transportation Manager for Fisher Associates overseeing their Syracuse office and their traffic engineering group and managing variety of transportation projects throughout New York and Pennsylvania.

Henry Litsky is Reconnect Rochester's Policy and Advocacy Coordinator. He coordinates Reconnect Rochester's growing advocacy activities and community mobilization efforts. This includes tracking legislative policy, maintaining our Monroe County Crash Map and Upcoming Street Projects Map, and educating community leaders to boldly advocate for a transportation system that provides mobility options and resource access for everyone through our Mobility Action Alerts. He graduated from the University of Rochester after completing an e5 tuition free fifth year focusing on transportation at UR and City of Rochester. He helped to co-found the Students for Equitable Transportation club and frequently attended public

meetings and submitted comments on proposed street design changes. Reconnect's Mobility Action Alerts allowed him to put what he was learning into action to try and make our streets safer.

Ed Brennan is the current President of the Albany Bicycle Coalition. He has helped organize numerous group rides in the Capital Region including annual Earth Day Rides and Rides of Silence for Cyclists that Have Been Killed or Seriously Injured. He was a long-time bike commuter. He has been a network engineer and a law librarian. Since his retirement he has been able to devote more time to bike touring around the US.

Benefits of Non-intrusive Detection at Traffic Signals

Session 11C, Rooms 2 & 3

Description: In 2022, New York State Department of Transportation (NYSDOT) started prioritizing the use of non-intrusive detection (i.e. video, radar, etc.) at traffic signals over conventional in-pavement detection like loops. Since then, NYSDOT has installed non-intrusive detection at over 1,000 intersections. Non-intrusive detection has many benefits such as worker safety, remote connectivity, flexibility, operational efficiency, on-demand data collection, corridor analytics, and advanced safety settings. This presentation will provide an overview of the benefits of non-intrusive detection, some case-study examples of safety and operational improvements at deployed locations, as well as "lessons learned" and maintenance considerations.
